

Higher Education Bursary - Deadline 22 November 2024

Applications for the 2024-2025 Higher Education bursary are now open.

You may be eligible to apply for a bursary if you are studying a Higher Education course. You can read more about the bursary provision in our Access and Participation plans, which you can read here [Fee Structure | East Sussex College \(escg.ac.uk\)](#)

You may be eligible for a bursary if you are an East Sussex College Group student enrolled on a Higher Education course (Foundation Degree, BA/BSc Degree, HNC/HND), and fall into one of the categories below:

1. You first enrolled on your current course Sept 2020-2024

You are eligible for a bursary if you fall into one or more of the following categories:

- Your household income is below £25,000 per year
- You are from a minority ethnicity, Roma, Gypsy or Irish Traveller
- Your permanent home address is in an under-represented area in Higher education (POLAR 4 Quintile 1 or 2 area) www.officeforstudents.org.uk/data-and-analysis/young-participation-by-area/search-by-postcode/
- You are in receipt of Disabled Students Allowance or applying for the DSA
- You are a carer for an adult & in receipt of a carers allowance
- You were in receipt of free meals at school
- You are a care leaver/estranged student

If you are from a minority ethnicity and/or if you live in and under-represented postcode, we will be able to assess this using the information you provide in your application.

Students can receive £200 for each category they fall into up to a maximum of £500 in each year of study (pro-rata for part-time students). Usually paid in 2 instalments in December and March subject to attendance. Students will need to reapply in each year of study.

2. You first enrolled on your current course Sept 2019

- You are eligible for a bursary if your household income is below £25,000 per year

Students can receive maximum of £500 in each year of study (pro-rata for part-time students). Usually paid in 2 instalments in December and March subject to attendance. Students will need to reapply in each year of study.

3. You first enrolled on your current course Sept 2018

- You are eligible for a bursary if your household income is below £42,875 per year.

Students can receive maximum of £500 if income is below £25,000. Students with income from £25,000—£42,875 will receive a maximum of £300. (pro-rata for part-time student). Usually paid in 2 instalments in December and March subject to attendance. Students will need to reapply in each year of study.

If you are repeating a year, use the year you first started the course, even if you then intermitted.

To apply for a bursary, you need to complete an online application and submit the required evidence using the link below:

The deadline for applications is 22 November 2024. We will not accept applications after the deadline. Awards are made on a first come first served basis. The fund will close when fully allocated.
