eVisas

UK Visas and Immigration (UKVI) has a new digital immigration system that has changed how individuals show evidence of their UK immigration permission. Documents such as vignettes and biometric residence permits (BRPs) are being replaced by **eVisas**. An eVisa is an electronic record of the person's identity and immigration status and it shows the conditions of their permission in the UK. All people with immigration permission will need to create a UKVI account to be able to use their eVisa.

Once the UKVI account has been created, the person can view and then share their permission through '**view and prove**'. [View and prove your immigration status: get a share code - GOV.UK](#)

To enrol on any course at East Sussex College, you will need to show your travel document or passport (if you have one) and eVisa sharecode at application stage. We will check your right to be in the UK using the sharecode. We cannot enrol someone until these checks have been completed.

- You must [link your current travel document](#) to your eVisa in your UKVI account and check details are correct. Personal details must be kept up to date.

Visitor Visa

A visitor is someone who wishes to visit the UK for up to six months.

If you are a **visa national**, then you must apply for the visa (entry clearance) before you travel to the UK.

If you are a **non-visa national**, you do not have to apply for entry clearance before travelling to the UK. You can apply to enter the UK as a visitor on arrival at the border.

Visitor visa vignettes are now digital. Therefore, holders will receive their visa as an eVisa.

Electronic Travel Authorisation (ETA)

An Electronic Travel Authorisation (ETA), is needed for **non-visa nationals** who want to travel to the UK as a visitor. An ETA gives a person permission to travel to the UK and is needed before travelling. The ETA only provides permission to travel to the UK, people with an ETA must also have permission to enter the UK on arrival.

An ETA costs £20.00 and allows multiple journeys to the UK for up to two years or until the person's passport expires – whichever is first. Once given, ETAs are digitally linked to a person's passport and allows a person to stay in the UK for **up to six months** at a time – including both short trips and longer trips.

ETA eligible national – An ETA is not a visa, it is a digital permission to travel to the UK. The quickest way to apply for an ETA is using the [UK ETA App](#).

Since 25th February 2026, the ETA requirement has been strictly enforced and carriers will not board eligible visitors without one.

Action required

All travellers to the UK – except British and Irish citizens – will need permission to travel to the UK in advance through either an ETA or an eVisa. What you apply for will depend on your course length and nationality.

We strongly encourage everyone to take the appropriate actions to benefit from a smoother travel experience, avoiding potential delays and complications or being refused boarding.

eVisa holders –check their UKVI account before travel, to ensure passports are up to date and linked to their eVisa – Enforcement deadline was 28 January 2026

Non-visa Nationals – must apply for an ETA via the official UK ETA app for permission to travel to the UK – Enforcement deadline was 25 February 2026
